Meeting was closed at 9:04am to discuss personnel topics. Meeting was reopened at 10:22am.

The sewer and water accounts were reviewed. Anticipated revenue and expenditures were discussed and a draft of the 2022 water and sewer accounts budgets were created.

Motion: by NE to enter into the wastewater agreement with Glencoe as presented at the City Council meeting on November 9 but with the change in the term of the agreement from 20 years to 10 years. All other content remained the same. Second by VW. All in favor.

Motion: by SS to have GS and LG discuss the zoning, ordinances and the City's options for 112 McLeod Avenue with the City Attorney. Second by DO. All in favor. VW abstained from voting. This motion was made to correct the motion made by Councilmember Wood at the November 8, 2021 meeting.

City Council members present: Dennis Oltmann, VeeAnn Wood, Neil Engelmann and Stacy Sohns

City Staff present: City Clerk/Treasurer Gerri Scott, and Public Works Director Scott Graupmann

All accounts, salaries, and anticipated expenditures were reviewed and discussed. A 2022 budget was created.

Motion: by NE to increase the Public Works Director's salary by 3% to \$46,370.88. Second by DO. All in favor.

Discussion/clarification on draft of new PTO policy to replace the vacation policy.

Motion: by NE to increase the clerk's salary by 4% to \$27.82 per hour and to provide 40 hours of PTO. Second by SS. All in favor.

Discussion/clarification of the Council pay for two budget meetings was discussed. It was determined the \$50 previously approved was for the budget meeting process, whether one or two meetings.

Motion: by NE to adjourn meeting. Second by VW. All in favor. Meeting adjourned at 1:57pm.
